Annual Parish Meeting

Every English Parish must have a Parish Meeting. This is not a Council meeting but a meeting of registered electors. The meeting will be held this year at 7.30pm on Thursday 16th May at 7.30pm in the Village Hall. This meeting is open to all residents and electors of Bourn who may by Law discuss



parish affairs, ask questions, put forward views and pass resolutions at the meeting. It is also your opportunity to hear reports from village groups and organisations and hear what's been happening, what is planned and how you can get involved. The agenda for the meeting will be published on the notice board seven clear days before the meeting. If you have an item for the agenda or something that you would like to raise at the meeting please contact the Clerk.

Bourn Parish Council is a Quality Council

Bourn Parish Council was delighted to be awarded its re-accreditation as a "Quality Parish Council" and at a recent meeting it was presented with its certificate. In order to achieve Quality Status, parish and town councils must demonstrate that they have reached the standard required by passing several tests.

Code of Conduct

Last year the Parish Council adopted the new Model Code of Conduct and details of all the members' Registers of Members Interests can be viewed on the village website http://www.bourn.org.uk

Parish Council Annual Audit

The external audit of the Parish Council's accounts will start on in early June 2013 and will be undertaken by Little John of London. Bourn residents have the opportunity to inspect and make copies of the Annual Return and supporting papers. For the year ending 31st March 2013 these documents will be available on reasonable notice, at mutually convenient times on application to the Clerk between 3rd to 31st May

Community Right to Bid

The Community Right to Bid allows communities and parish councils to nominate buildings or land for listing by the local authority as an asset of community value. An asset can be listed if its principal use furthers (or has recently furthered) their community's social well-being or social interests (which include cultural, sporting or recreational interests) and is likely to do so in the future. When a listed asset comes to be sold, a moratorium on the sale (of up to six months) may be invoked, providing local community groups with a better chance to raise finance, develop a business plan and to make a bid to buy the asset on the open market.

The parish council will be drawing up a list of assets over the next month and welcomes suggestions of suitable assets from parishioners.

Parish Plan Working Group

The Working Group are working on three 3 main areas at the moment. These are a local cinema, community car scheme and parking.

Play equipment, safety surfacing and inspections

Quotations are being sought for safety surfacing under the play equipment at the Hall Close play area.

The Parish Council is delighted to report the appointment of Mr Frank Haxton as its Operational Inspector. In brief is role is to his role is to be directed by and report to the Parish Council on matters relating to the play equipment in the village, assist in monitoring and keeping the equipment as safe as necessary and help develop the areas.

If anyone sees any problems with the play equipment or anything amiss on either the Jubilee playing field or the Hall Close play area please contact the Clerk.

The District Council has been urged to make some improvements to the open ditch at the Hall Close play area including fitting new grilles and the District Council should be undertaking this work shortly.

S137 requests received for financial support for inclusion In the FY2014 budget

Requests from the Parochial Church Council and also the Merribourn Club have been considered. It was agreed that the Parish Council could not fund a higher amount than this year and so the following amounts will be released after 1st April

Sustainable Parish Energy Partnership

Bourn Parish Council is increasing its involvement with SPEP (Sustainable Parish Energy Partnership) who work with local communities to encourage low carbon and sustainable living. The Parish Council is organising a Sustainable Living Event in the Autumn, and has already booked the use of a thermal imaging camera for a week in November to gauge the efficiency of saving energy in homes in Bourn. Allotment News

Bourn Allotments are at the end of Hall Close, below Bourn Hall. Currently there are 10 half-size plots and one quarter-size plot. (A full-size plot would be 250 sq metres.) This provision is well below S Cambs recommended allotment area for the number of households in Bourn, so it is not surprising that we have a waiting list of several people wanting new allotments.

The Parish Council and Bourn Allotments Association have approached various landowners but, so far, have not found any land for more allotments. If anyone knows

of any land available for rent, lease or sale, we would be interested to hear. In the meantime, if you are interested in having an allotment in Bourn, you can join the waiting list, ready for the time when we do have more plots.

Having an allotment is not all hard work and digging – we do have regular gettogethers for BBQs and stir-fries, featuring our produce, and an annual gathering known as "Midwinter Madness" when we are warmed by mulled wine, mince pies and hot soup.

A recent development has been the start of a collaboration with Bourn School. 3 volunteers from the allotments met with some of the schoolchildren to help them plan some raised beds at school, where each class can grow some produce. These volunteers will offer practical help and advice throughout the growing season.
