An Appeal for Volunteers from the Alzheimer's Society

Here at Alzheimer's Society, we want to connect to as many people as possible who are affected by dementia. In rural areas, this can often be hard to get our message out there which is, "we are here for you".

As a result of the difficulties faced from rural areas, we are currently looking for volunteers to help raise awareness of Dementia and Alzheimer's Society in their local areas. This can be achieved by ensuring local GPs, health centres, community centres and even local shops have up to date information from us. The role would involve supplying these places with the information through the forms of posters etc. that would be supplied to you by our Information Worker. The Information Worker will be managing you to ensure you have the resources available to raise awareness of Dementia and Alzheimer's Society.

The volunteering opportunity has no fixed hours, and can be done in your own spare time where available.

Along with this opportunity, we also have volunteering opportunities with South Cambs Dementia Action Alliance. This is a group that consists of local business, health departments, etc. that ensure South Cambs is a dementia friendly area. The opportunity would involve increasing the size of the group by contacting local businesses/community groups to see if they would like to know more about becoming dementia friendly and assisting them on their way with support from the Cambridge Dementia Action Alliance Coordinator.

Again this is another volunteering opportunity that has no fixed hours and can be done in your own spare time. Meetings of the South Cambs Dementia Action Alliance often take place bi-monthly.

The Greater Cambridge City Deal: Tackling Cambridge Congestion

South Cambridgeshire Local Plan

An updated Hearings Programme (version 11, 14 July 2016) has been published by the Inspectors giving details, including dates where available, on a number of future hearings blocks for both the Cambridge Local Plan and the first South Cambridgeshire Local Plan only examination hearings. Hearings about issues specific to our district will start on **1 November 2016**. Inspectors' Matters and Issues for the hearings now with specific dates have also been published (Matters SC2, SC5A, SC5B & SC8).

Greater Cambridge City Deal

The Greater Cambridge City Deal is an agreement between Government and a partnership between South Cambridgeshire District Council, Cambridge City Council and Cambridgeshire County Council with Cambridge University and the Greater Cambridge Greater Peterborough Enterprise Partnership to secure up to £500 million to support growth in Cambridge and South Cambridgeshire. A number of transport projects are being developed with public consultation at key stages. The City Deal is currently consulting on:

Tackling Cambridge Congestion

The City Deal Team is seeking people's views on a planned package of measures to tackle peak-time congestion in Cambridge which will significantly improve public transport, cycling and walking journeys. The eight point plan to tackle congestion in Cambridge includes:

- Better public transport and Park and Ride
- Better cycling and walking
- Peak- time congestion control points
- Workplace Parking Levy
- On-street parking controls within Cambridge
- Smart technology real time traffic alerts
- Travel planning
- Public space and air quality.

A14 Community Fund

As part of Highways England's commitment to support local communities, the A14 Cambridge to Huntingdon project team has launched the A14 Community Fund. The focus of the Fund is to bring communities closer together, reflecting the fact that the scheme will have a lasting impact on those living in the A14 corridor. The Fund will provide up to £10,000 in funding, for not-for-profit organisations, for projects which respond to the transformation that the new road will bring to the area. Electoral Review of Cambridgeshire: Final Recommendations

The Commission has now completed its review of Cambridgeshire County Council. A summary of the Commission's report setting out their final recommendations for Cambridgeshire County Council has now been published and is available on their website, www.lgbce.org.uk. An interactive map of final recommendations is available at www.consultation.lgbce.org.uk

The changes proposed for Cambridgeshire County Council must now be implemented by order subject to Parliamentary scrutiny. A draft Order – the legal document which brings into force the recommendations – will be laid in Parliament. The draft Order will provide for new electoral arrangements for Cambridgeshire County Council to be implemented at the local elections in 2017.
