#### Updates from South Cambs District Council Greater Cambridge - Local Plan

We are working with Cambridge City Council to prepare a joint Local Plan for the Greater Cambridge area. Both the Councils' current adopted Local Plans (2018) include a policy which makes a commitment to an early review of those Plans to commence before the end of 2019.

One of the first stages of the new joint Local Plan is an Issues and Options consultation. This is due to begin on 25 November and run through until the New Year. <u>A report</u> was published on Monday 23 September, giving details of the Issues and Options

consultation. This includes the themes the Local Plan will explore. Councillors will debate the report in September and October and will be asked to agree to consult local people.

We will publish more information about the consultation on our website when it begins on 25 November to help people have their say. We are working especially hard to get information across to groups that have been traditionally hard to reach and engage in planning issues.

#### *Community Chest Grants*

The second tranche of the Community Chest Grant opens on Tuesday 1 October. Community groups, charities, voluntary sector organisations and Parish Councils with fewer than 160 registered electors can apply for a share of £29,000.

From Tuesday 1 October there is a slight change in the grant's criteria. This means that our committee reserves the right to supersede the clause that only parish councils or parish meetings of more than 160 registered electors can apply, should good cause be shown. For example, if the parish council or parish meeting has multiple settlements, and the application pertains to any one of these which satisfies the 160 elector threshold, or registered electors are within 10% of threshold.

#### EU Settlement Scheme

Please help us spread the message about the Government's EU Settlement Scheme. If you are an EU, EEA or Swiss citizen you are now able to apply to the EU Settlement Scheme to continue living in the UK after 30 June 2021.

The Government has provided details of the Settlement Scheme, including how to apply <u>on their</u> <u>website</u>. Guidance on the settlement scheme is available in all 26 EU languages.

If there is a deal, EU citizens will need to register under the scheme by 30 June 2021. If the UK leaves the EU without a deal the deadline for applying will be 31 December 2020.

#### Speedwatch news

We have fifteen volunteers to date, the majority of whom have taken part in at least one roadside session. All volunteers have taken part in a training session with Cambridgeshire Police.

Having started in April, we have now held fourteen sessions at different locations around the village. Only those volunteers who are 'on duty' on the day know where these are situated.

To date we have recorded over 2,100 vehicles in total during the sessions, all of which were within the 30mph areas of the village. Of those recorded we have reported 180 for speeds in excess of



35mph, the highest being, on three occasions, 50mph. Vehicles travelling at speeds between 30mph and 35mph are recorded for statistical purposes, but not reported.

The total numbers of vehicles recorded at any session, whether exceeding the limit or not, will help the Parish Council with the evidence required in their efforts to get the County Council to install better traffic calming through the village by highlighting the amount of 'rat-running' at busy times on the nearby major roads. These numbers are only valid for vehicles travelling in the direction being monitored; there are just as many vehicles travelling the in opposite direction showing just how heavy the traffic often is.

There will always be room for more volunteers as it is not always possible to get the minimum requirement of three available for any one time or date. If you'd like to volunteer, or for more information, please contact the co-ordinator, Cllr Les Rolfe.
